We contributed to a rule of law strategy for UNISFA; supported detention management by Community Protection Committees in Abyei; and engaged in critical prison security and reform initiatives in CAR, Libya and Somalia.

Furthermore, in the framework of the Global Focal Point for the Rule of Law (again: Happy 10th Anniversary GFP!), of which the Department of Peace Operations (DPO) is a co-lead entity, we were pleased to support UNDP in their reform efforts for the prison service of Djibouti.

A Snapshot of Operations and Achievements in 2022:

SUPPORTING UNITED NATIONS TRANSITIONS

MONUSCO (DRC)

This deployment (February - April) strengthened the relationship between the United Nations and the World Bank in the DRC and provided strategic planning materialize and support to cooperation, inter alia through a draft Memorandum of Understanding (MoU). The deployment, which was co-sponsored by MONUSCO and the Humanitarian-Development-Peacebuilding Partnership Facility, specifically aimed to support the transition of MONUSCO by advancing sustainable stabilization support from the World Bank in geographic hotspots in the DRC, including in the rule of law area.

In line with the Transition Plan of MONUSCO and in the context of shifting conflict dynamics and an increase of serious crimes committed in the DRC, this JCSC deployment (October - December) helped the Justice Support Section of MONUSCO advance transition initiatives. Outputs included a note identifying priority areas for the rule of law team's strategic and operational engagement, especially vis-à-vis the implementation of the United Nations Joint Justice Reform Support Programme and efforts to address destabilizing crime. This assignment also served as follow-up to a previous JCSC deployment that provided MONUSCO with the report 10 years after: Options for the future of the Prosecution Support Cells (PSCs) Programme in the context of MONUSCO's transition.







STRATEGIC RULE OF LAW PLANNING/PROGRAMMING

UNITAMS (SUDAN)

In the aftermath of the October 2021 military takeover, ICSC, during two deployments to UNITAMS in co-location with UNDP (January - March and April - June), helped re-define common rule of law priorities in the context of the multifaceted crisis in line with the humanitarian-development-peacebuilding nexus. More specifically, following extensive consultations including with field-based United Nations personnel, JCSC led the development and finalization of a joint programmatic framework and related joint programme document with a United Nations Country Team (UNCT) gender equality marker 2, based on refocused priorities for the United Nations system in Sudan. JCSC also helped deepen integration and advised on collaboration and coordination modalities. The joint programme is now being coordinated by UNDP and implemented jointly with UNITAMS, OHCHR, UNHCR, UNODC, UN Habitat, UNICEF, UNFPA, UN Women and UNOCT, in cooperation with the Team of Experts on the Rule of Law and Sexual Violence in Conflict.

UNISFA (ABYEI)

A first JCSC deployment in Abyei (February - May) led to the development of sustainable tools (guidance manual, internal rules, training curriculum) for the management of the detention facilities and of Community capacity building Protection Committee (CPC) members running these facilities in the absence of formal structures in Abyei. Furthermore, the JCSC deployment also contributed to the development of a comprehensive United Nations rule of law strategy for Abyei. This strategy, amongst others, enables UNISFA and the UNCT - in an integrated fashion - to advance the mandate of UNISFA with respect to the protection of civilians in this hotspot area.

In a second deployment (commenced in November), JCSC is supporting UNISFA in the implementation of recommendations from previous with respect assessments improving detention conditions, including for women inmates, and security at local detention facilities. JCSC is also, in line with the Mission's protection of civiliansrelated mandate, strengthening the capacity of the newly established CPC in the northern part of Abyei in the areas of human rights and detention management.



MINUSCA (CAR)

This JCSC deployment (May - September) supported the Mission to strengthen the Special Criminal Court (SCC) - a court consisting of national and international magistrates mandated to prosecute and try the most serious crimes committed in the country since 2003. Technical, operational, and strategic support provided to the Justice and Corrections Section of MINUSCA and UNDP included the drafting of a Practical Guide on the Management, Monitoring and Evaluation of Programmatic Funds, the finalization of four MoUs between MINUSCA and its implementing partners, and the identification of priorities for support to the SCC in the coming year. Lastly, to prepare the annual Steering Committee of the SCC, chaired by the Minister of Justice, JCSC contributed to evidence-based recommendations for the Committee's approval, including in relation to the extension of the mandate of the SCC for another five years (which was endorsed by the Government).

PRISON SECURITY AND REFORM

This deployment to Djibouti (February - April) was in support of the Djibouti Justice Project of UNDP. In close cooperation with national counterparts, JCSC developed strategic and operational tools and policies to enhance prison management and the capacity of Djibouti's penitentiary system to implement them. This included a monitoring tool for penitentiary services, standard operating procedures and guidelines for the implementation of prisoner reintegration programmes. The tools and policies, once implemented, will facilitate ongoing prison reform efforts that meet international human rights standards.

Carried out from May to July, this JCSC deployment provided support to the Corrections Unit of MINUSCA, especially through the development of a training plan for the continuous education of CAR prison staff at all levels as well as human resources and security management tools for the national penitentiary service. This included a prison security procedures manual to guide the penitentiary service in day-to-day security routines and practices in compliance with the United Nations Minimum Rules for the Treatment of Prisoners (the Nelson Mandela Rules). The deployment was undertaken in the framework of the national Prison Demilitarization Strategy, which MINUSCA – also through previous JCSC involvement – continues to support with the aim of professionalizing a sustainable prison service in CAR.

UNSMIL (LIBYA)

This deployment to Libya (July - September) provided critical strategic surge capacity to support UNSMIL in assisting the Libyan prison authorities to improve prison conditions and reduce arbitrary detention. The deployment resulted, *inter alia*, in the development of a thorough assessment report on prison security with concrete recommendations, including implementation mechanisms. Moreover, on behalf of UNSMIL, JCSC engaged with the UNCT and other international partners in the preparation of the Second High-Level Symposium on Arbitrary Detention, a major policy forum to tackle one of the greatest political rule of law challenges facing the country.

UNSOM (SOMALIA)

This deployment (September - November) produced an in depth assessment of the corrections training framework in Somalia as part of a Federal Corrections Model and the Prison Training Academy in Garowe/Puntland. The assessment recommended a unified and comprehensive training strategy to be undertaken by the Federal Ministry of Justice of Somalia, with the Federal Member States and the Custodial Corps. The assessment identified the need for a political agreement between Federal authorities and the Federal Member States on the designation of a Federal Academy. Lastly, the deployment suggested a process for engaging civil society on prisoners' rights issues that could be applied in all Federal Member States.

INFORMING POLITICAL/RULE OF LAW ENGAGEMENT ON JUDICIAL GOVERNANCE AND ACCOUNTABILITY FOR CONFLICT-RELATED SEXUAL VIOLENCE

UNOWAS

Following up on a deployment carried out in 2021, JCSC remotely finalized a research paper on judicial governance in West Africa and the Sahel, highlighting trends related to the instrumentalization of the judiciary and formulating a number of recommendations to further strengthen the political and rule of law engagement of UNOWAS on this issue. The research and its recommendations were made available to the UNCT in the region to inform the design of new rule of law programmes.



UNSOM (SOMALIA)

From October to December, JCSC deployed to UNSOM to carry out research and consultations on judicial independence and accountability for conflict-related sexual violence (CRSV) to inform the Mission's political and rule of law engagement on these issues. The research was based on a desk review and analysis, interviews, focus group discussions with justice actors, displaced women, youth and community representatives, as well as a two-day roundtable discussion on CRSV with civil society representatives from across the country. In addition, field trips were undertaken to Hargeisa, Somaliland, and to Garowe, Puntland. In carrying out this deployment, JCSC worked with the Women Protection Unit of UNSOM as well as the Team of Experts on the Rule of Law and Sexual Violence in Conflict.

MANAGEMENT

UNITAMS (SUDAN)

Two deployments to UNITAMS between June and August provided the Mission with managerial rule of law capacity during the temporary absence of the Chief of the Mission's rule of law portfolio. The joint United Nations rule of law programme was finalized during the deployment period. Furthermore, clear entry points and structural requirements were worked out to position the rule of law work for the gradually reassuming political talks leading to a constitutional process. Lastly, a partnership agreement with the Geneva Centre for Security Sector Governance (DCAF)/International Security Sector Advisory Team (ISSAT) was advanced to conduct a thorough assessment of Sudan's rural courts, given their high relevance for the delivery of justice for marginalized communities.


TRAINING AND INTERNATIONAL CONFERENCES

JCSC continued to strengthen its skills to better support its clients. In that regard, JCSC – along with other OROLSI standing capacities – participated in the United Nations Interregional Crime and Justice Research institute (UNICRI) workshop *Good Practices on the Nexus between Transnational Organized Crime and Terrorism* held in Brindisi from 11 to 13 April 2022.

In December 2022, JCSC contributed to the thematic discussions of the Commission on Crime Prevention and Criminal Justice (CCPCJ) on the implementation of the *Kyoto Declaration*, specifically on Pillar 2 on *Advancing the Criminal Justice System*. JCSC highlighted the role of United Nations peace operations in improving prison conditions and reducing reoffending in post-conflict settings and called on Member States to implement the United Nations Common Position on Incarceration. The thematic discussions will inform the work of the CCPCJ at its 32nd session in May 2023. JCSC stands ready to support United Nations clients in the implementation of the United Nations Common Position.



JCSC also engaged in rule of law policy discussion forums. For instance, JCSC attended the International Corrections and Prisons Association (ICPA) Annual Conference in Orlando, USA, from 23 to 28 October 2022, and engaged with corrections policy makers and practitioners on global trends, including on sustainable and environmentally friendly prison management. It co-presented, along with JCS and Health Through Walls, the draft United Nations Rapid Assessment Tool and Supplemental User Guide for Prison Healthcare. JCSC is ready to assist United Nations clients in the usage of this unique and forward-looking tool and guide.
